**Disciplinary Contract:**

The staff at Littlejohn Community Center is expected to respect the dignity of the children and conduct themselves as adult role models. The program does not use any strategy that hurts, shames, belittles, threatens, intimidates, or forces a child.

Physical contact as disciplining a child is avoided unless it is necessary to restrain a child from harming himself or another.

Corporal punishment is not allowed. The program does not permit using food as a reward or punishment. The program does not use or withhold physical activity as a punishment.

When correcting a child's behavior, the staff verbalizes and demonstrates what should be said or done rather than focusing on unwanted behavior. The staff also explains why the children are asked to follow the rules. The children are expected to respect the staff and each other.

If the staff cannot resolve ongoing or serious behavior issues (such as aggressive, abusive, disturbing, or destructive acts), the director will discuss the problem with the parents. This will serve as the first offense, which is a warning. The parent will receive documentation of the warning. If the child's behavior does not change in a reasonable time, the director will issue a 2-day suspension from camp. The parent will receive documentation of the suspension. If the problem continues and cannot be resolved after the suspension, the director will give the parent/guardian a notice of dismissal from the program.
