Your child MUST be a minimum of Kindergarten age. Majority of students will take the bus to the community center and staff will be there to meet them at the bus stop, however students may be dropped off or walk if given permission by guardians. Students will be provided with a meal/snack each day. We have 20 spots available and it is on a first come first serve basis only. You must come in person to Littlejohn Community Center to drop off this completed form and fee (cash or money order only). Our start date is September 9th.

The afterschool program operates in accordance with Littlejohn Community Center policies regarding early school closing in the event of an emergency weather condition. Discipline:

The staff of Littlejohn Community Center are expected to respect the dignity of the children and conduct themselves as adult role models. The program does not use any strategy that hurts, shames or belittles children. The program does not use any strategy that threatens, intimidates or forces a child physical contact is disciplining. Physical contact is avoided unless necessary to restrain a child from harming themselves or another student.

Corporal punishment is not allowed, the program does not permit the use of food as reward or punishment and the program does not use withhold physical activity as a means of punishment. When correcting a child's behavior the staff verbalizes and demonstrates to the child what should be said or done rather than focusing on the unwanted behavior, the staff also explains the reason for the rules children are asked to follow. The children are expected to respect the staff and each other.

Littlejohn Community Center does not tolerate students putting their hands on anyone unwanted for any reason ever (fighting, pushing, shoving: etc) The first infraction will be a conversation with student and staff. Second infraction is a call home and third infraction is an automatic dismissal from the program for one week. Beyond three infractions students will be asked not to return to the program.
